PAYMENT/DEPOSIT:

A \$100 deposit is required to reserve the travel trailers.

All rental charges are paid in advance or on the day of rental.

Hillside Campers L.L.C. accepts cash, credit/debit card, or check. The actual credit card in the renters name must be present at departure. Company checks or personal checks are not accepted unless prepaid 15 days in advance.

Your Security Deposit will be either be refunded at time of return or by mail within 30 days of return. If camper is returned in acceptable condition.

CANCELLATION:

From the date of your reservation to 30 days prior to your pick-up date. Hillside Campers L.L.C. will refund your deposit. If you cancel within 30 days of your scheduled departure, do not show upon time for pickup or are unable to comply with our requirements at departure, **NO REFUND** will be made.

OTHER IMPORTANT INFORMATION:

- A) The person named on the Reservation Application must be 25 years of age and is the only person authorized to sign our rental agreement and drive or tow the trailer off our lot;
- B) Hillside Campers L.L.C. reserves the right to substitute a rental of equal or greater value, or refund your deposit payment due to unavailability of the rental unit; We will not be held liable for any other charges.
- C) No refund will be issued if you return the rental unit prior to your scheduled return date;
- D) Smoking or Pets are prohibited in all units. Deposit will be forfeited if we find any signs of pets or smoking in our units.
- E) Generally, all rentals will be available for pick up only after 3pm and any departure available by 9pm is considered on time.
- F) Rental units must be returned prior to noon, unless prior arrangements are made with Hillside Campers L.L.C.

INSURANCE:

You must have current liability coverage on your tow vehicle. At departure, a copy of your tow vehicle insurance card will be made. The renter's name must match the name on the insurance card. By state law,

liability insurance goes with the tow vehicle. Collision and Comprehensive damage coverage is included with the trailer rental but you are responsible for the first \$1000.

Inside damage is NOT covered nor is negligent damage or awning damage.

I have read and agree with all of the conditions on this reservation application and all the information I have given is true and correct. I understand you may perform a credit investigation and I hereby authorize you to receive information on my credit from others. The credit card used online is issued in my name with the billing address the same as listed above. I also authorize you to charge my credit card listed above for the reservation down payment and I have read and understand that all or part of that fee may be retained by Hillside Campers L.L.C. in the event of cancellation according to the cancellation policy stated above. I also understand that Hillside Campers L.L.C. may keep the deposit if the camper is not returned in satisfactory condition.

I have read ***"The Requirements and Specific cautions for Towing Trailers"*** and ***"Travel trailer pickup and return conditions"***

It is important that the person whose name is on the rental application be in our office in person on the day of departure to sign the Rental Agreement.

Make sure you have with you:

1. Your Valid Drivers License
2. Your Tow Vehicle Proof of Insurance. The trailer is insured with a \$1000 deductible but the liability goes with the tow vehicle. Please bring a copy of your declaration page from your insurance company.
3. The credit card you provided on the reservation application. We cannot accept a card in someone else's name nor can we use merely the number you provided on the reservation application. We will require a signed imprint of the card to be left with us. This card must be in the name of the renter.

Your tow vehicle must be all ready to tow on the day of pickup. We want to inspect the tow vehicle PRIOR to the day of pickup to insure its readiness. You will need to have the correct wiring and brake control installed and an adequate hitch.

We have scheduled your pickup on the date listed on your reservation contract. The vehicle will be available for pick up between 3pm and 8pm in the afternoon. ***Please call us the day before to set a specific time.***

By scheduling our pick-ups, we can process your rental faster and get you on the road quickly to start enjoying your RV adventure.

Returns are always by 12 noon (unless arrangements are made prior to departure). It is necessary for us to have as much time as possible to clean and safety check all rentals. You will be given a personal tour of the travel trailer. Be sure to schedule enough time for finalizing paperwork and vehicle instruction.

If you plan to drop off the trailer when we are not open, remember you are still responsible for any damage until the unit is pulled into our yard during business hours. Please park in the designated rental return area.

Upon return the interior must be clean. Interior cleaning will be charged at \$50.

Do not use abrasive cleaners as they will scratch and cause damage.

REQUIREMENTS AND SPECIFICATIONS FOR TOWING TRAILERS

All trailers except the tent trailers require **Electronic Brake Controller** in the tow vehicle. All tow vehicles must be in good running condition and equipped with tires to carry the extra weight. You are responsible for determining the towing capacity of your tow vehicle. The tow vehicle's engine, transmission, suspension, steering, front end alignment, tire rating and tire condition, if not properly maintained, may affect your vehicle's ability to tow.

Trailer Hitch Requirements:

Travel Trailers : Minimum Class IV (750 lbs. HW, 7500 lbs. GVRW)

Ball size: 2 5/16" or 2" depending on the unit. (Hitch gear is included with this unit)

You must have current liability coverage on your tow vehicle. At departure, a copy of your tow vehicle insurance card will be made. The Renter's name must match the name on the insurance card.

TRAVEL TRAILER ITEMS AVAILABLE FOR RENT

All Trailer rentals include a broom and dust pan, small dish soap, small general cleaner, a roll of paper towels and a roll of toilet paper.

The toilet is charged with chemical.

General Requirements: Customer agrees not to drive in a careless or negligent manner, nor drive while under the influence of alcohol or drugs, nor permit operation of the vehicle by any person except those signed to the agreement. Customer further agrees not to use, or permit use of the rental for unlawful purposes. **Customer will hold Lessor harmless from any and all fines, forfeitures and penalties incurred during the rental period caused directly or indirectly by negligence, misuse or carelessness. Customer further agrees to indemnify and hold harmless the Lessor from and against any and all claims for loss of, or damage to property, or injury to persons, including death, resulting from the use, operation or possession of the rented unit.**

Unless prohibited by law, you release us from any liability for consequential, special or punitive damages in connection with this rental or the reservation of a vehicle.

Customer understands that the number of passengers who may lawfully travel in a motor home is limited to the number of seat belted seats in the motor home. Customer agrees to abide by that limit.

By signing below you acknowledge that you have been given an opportunity to read the terms of this Agreement before being asked to sign. Your signature permits us to process a credit voucher in your name for all rental charges due under this Agreement.
